

# Terms and Conditions for Nova Parent surrogacy agency

## 1. Acceptance of Terms

By using Nova Parent surrogacy agency 's services or website, you agree to these Terms and Conditions. If you disagree, refrain from accessing our services.

## 2. Scope of Services

- Surrogacy Coordination: Matching intended parents with surrogates, medical/legal support, and overseeing agreements.
- Medical & Legal Assistance: Partnering with clinics, lawyers, and hospitals to comply with Ukrainian surrogacy laws (e.g., "Family Code of Ukraine", "Medical Standards").
- Consultations: Providing guidance on eligibility, costs, and legal requirements.

## 3. Eligibility

- Intended Parents: Must meet Ukrainian legal criteria (e.g., heterosexual married couples, medical necessity for surrogacy).
- Surrogates: Must pass medical/psychological screenings per Ukrainian regulations.
